USPTO awarded two veteran-friendly designations

It was apt timing that during the month of Veterans Day, the USPTO was awarded two veteran-friendly designations.

First, the agency was named a <u>2024 U.S. Veterans</u> <u>Magazine Top Veteran-Friendly Government Agency</u>. Some of the information that was taken into consideration included percentages of veterans/women veterans/Csuite veterans, retention rates, presence of a veteran hiring coordinator, affinity group, military outreach, and veteran career development opportunities.

"U.S. Veterans Magazine presents a compilation of esteemed agencies that have received recognition for their exceptional dedication to fostering inclusion and equality for our veteran community. These agencies have exemplified excellence in cultivating an inclusive workplace culture and have achieved significant advancements in promoting equal opportunity and

equity within their organizations. We take great pride in showcasing these industry leaders and emphasizing their unwavering commitment to championing equality and creating a more inclusive workplace for veterans."

Next, the USPTO is one of only two federal agencies (Customs and Border Protection is the other) selected for the <u>Military.com Top 25 Veteran Employers for the 2025</u> list. Although our workforce percentage of veterans is lower than some others on the list, we were selected due to our strong employee experience and robust military outreach.

Included in the write-up for the agency is a section about the **USPTO Military Association**: "The agency's robust veteran and military spouse hiring program is complemented by a 280+ member military association, which offers mentorship, career growth opportunities and a sense of community. The agency also hosts panels and summits on topics such as PTSD, Hispanics in the military and service branch celebrations and organizes annual Memorial Day and Veterans Day programming. Weekly virtual 'coffee chats' further foster connections among veteran employees."

We're proud of our agency's engagement and growing positive reputation within the military community.

UMA hosts Veterans Day celebration

Our USPTO Military Association (UMA) hosted a Veterans Day program at the Alexandria campus on November 7th to honor America's veterans for their willingness to serve and make sacrifices for the nation. Joined by the Patenteers, the USPTO chorus, as well as a jazz ensemble from a local school, our colleagues offered their thanks for those who have served in our armed forces.

UMA Executive Sponsor and agency Chief Administrative Officer Fred Steckler opened by sharing a brief history of the UMA and veteran hiring at the USPTO. The veteran workforce at the agency now numbers over 1,000. He emphasized the UMA's impact cannot be understated.

"It's not enough to simply hire veterans; you have to create a

community for them," he said.

Added USPTO Deputy Director Derrick Brent: "The UMA is a shining organization in the agency. [Veterans] have shaped our society both in and out of uniform."

Veteran contributions were also emphasized by the program guest speaker, retired Army Lt. Gen. Leslie Smith, who offered a keynote address about organizational trust.

"The trust that veterans bring to organizations is so critical [...] we must not only encourage it, but require it," he said. "That's what veterans bring to the table...a legacy of loyalty and service."

NSBE & UMA mock interview program contributes to promotion success

The interview is one of the most nerve-wracking parts of the job application process. Even seasoned professionals with impressive credentials can become nervous when put on the spot, formulating responses, remembering to maintain eye contact, avoiding filler words, and more. Longtime USPTO Military Association (UMA) member Valentin Neacsu conquered those nerves and earned a promotion this year thanks to a Voluntary Employee Organization mock interview initiative.

Neacsu served as a patent examiner in Technology Center (TC) 3700 for nearly a decade before pursuing a position as a Supervisory Patent Examiner (SPE) in another TC. "Having been advised by several of my friends and mentors that interview practice was extremely important, I enthusiastically embraced the opportunity to participate in the Mock Interview Program... as soon as it was announced," he said.

Most people do not have a regimented way to practice or simulate the interview process, leaving even the most qualified applicants with impressive resumés to flounder in such a stressful environment. To combat this problem, the National Society of Black Engineers (NSBE) - USPTO Chapter partnered with the UMA to form the NSBE & UMA Mock Interview Initiative in 2023. The initiative was founded to help make any USPTO colleague a stronger interviewee and applicant for any position they apply for, supporting the agency's focus on professional development and career growth. Neacsu has made professional growth a central goal and priority throughout his career.

Neacsu was born and raised in Romania. After graduating a military high school, he attended the Romanian Military Technical Academy (MTA). He served as a military instructor and manager of a small research lab at the MTA and eventually was honorably discharged from the military as a first lieutenant and was admitted into a graduate program at the University of Delaware in the early 2000s. Neacsu graduated with a Ph.D. in Mechanical Engineering and then worked as an engineer at a defense contractor in Massachusetts. He said it "proved to be an outstanding learning opportunity."

Eventually, Neacsu moved with his family to Northern Virginia, where he learned about the USPTO and has served here ever since.

"After I became a Primary Examiner, I realized how much I enjoyed training other examiners, which is why I signed up for career development details," Neacsu explained. "The same realization made me pursue a managerial position, given that the main responsibilities of a Supervisory Patent Examiner include coaching and mentoring and training in the most general sense."

Early on as a patent examiner, Neacsu had "an interesting conversation" with Sieg Chencinski in the Madison Atrium. This interaction led him to join the UMA soon after joining the PTO:

Sieg was an honorary UMA board member, happy to talk with anyone about the association and recruit new members. Sieg and I found out that we shared several things in common: though in different centuries and under different conditions, Sieg and I were both born in the same Eastern European country and immigrated to the United States. We both served in the military in our youths: his military service with the US Air Force extended for many years, mine with the Romanian military was much shorter. So I call Sieg my UMA sponsor, because he's the one who invited me to join, which I did right away.

Ever since then, Neacsu has been an enthusiastic member of the UMA, participating in various events and programs, such as the mock interview program.

During each mock interview, three panelists ask the

interviewee questions and judge their responses. Each session typically consists of three general, important interview questions that are pulled from different lists and resources. After all three questions are answered, the interviewee is given the chance to ask a question or make a comment about the panelists, as would happen in a real interview.

The intention is to provide participants with a structured format that feels like a real interview while keeping them on their toes. All mock interviews are conducted virtually, and the USPTO Digital Media Service video records them, letting the participant see their performance. Additionally, all three panelists give constructive feedback to the interviewee afterward using a rubric that gauges appearance, communication, body language, and question responses, allowing the participant to view the video recording and compare it to the panelists' comments. Applicants can and are encouraged to sign up for three interview sessions, allowing them to improve and build confidence with every subsequent one.

Neacsu recently became a supervisory patent examiner. To get the position, he had to endure two rigorous interviews with tough panelists and judges, and says he's thankful he prepared through the mock interview program first.

Neacsu said he thought the mock interview program "was absolutely outstanding, a lot more than what I had hoped for." He participated in "three separate mock interviews on three different dates," and he was interviewed by many qualified and experienced people from the UMA and NSBE.

"After each interview, each panelist shared their opinions and made specific recommendations of what I could do to improve my performance in future interviews," Neacsu said. "The feedback was offered in a friendly, honest, and professional way, and addressed a range of aspects from structure/content of my answers to form and overall demeanor. These suggestions were very valuable, as they captured details that were impossible for me to become aware of on my own."

Neacsu said that having to go through a realistic simulation of the job interviewing process prepared him well for his actual interviews. He said, "I am immensely grateful to the volunteers who participated in this program, as I credit their collective insight with my improvements in presentation skills, and with my being eventually selected for a new SPE position."





Headline highlights: A look at news affecting veterans

<u>VA proposes rule to expand access to its Program of Comprehensive Assistance for Family Caregivers</u>: The U.S. Department of Veterans Affairs announced its intent to expand access to its Program of Comprehensive Assistance for Family Caregivers (PCAFC) — a program that provides family caregivers of eligible veterans access to services and supports, including training and education, financial assistance, health care coverage, beneficiary travel, peer support, and more.

VA funds first study on psychedelic-assisted therapy for veterans: VA will fund a study on

Methylenedioxymethamphetamine-assisted, or MDMA-assisted, therapy for post-traumatic stress disorder and alcohol use disorder among veterans.

<u>Veteran homelessness reaches record low, decreasing by 7.5% since 2023</u>: VA and the U.S. Department of Housing and Urban Development, and the U.S. Interagency Council on Homelessness announced results of the 2024 Point-in-Time (PIT) Count, which show a record low in Veteran homelessness since measurement began in 2009 and a 7.5% decrease since 2023.

TRICARE Regions Are Changing Jan. 1, 2025: Jan. 1, 2025, marks the start of health care delivery under TRICARE's new regional contracts. There will be changes to the TRICARE regions in the U.S. as part of the new contracts. While there will still be two TRICARE regions, six states currently in the East Region (Arkansas, Illinois, Louisiana, Oklahoma, Texas, Wisconsin) will move to the West Region.

SBA's Interagency Task Force to Address Veteran Small Business Development at Dec. 11 Public Meeting: The IATF Advisory Committee independently offers advice and recommends policy related to veteran-owned small business development to the SBA Administrator, the Assistant Administrator for SBA's Office of Veterans Business Development, Congress, the President, and other U.S. policymakers.
